This page contains the terms & conditions. Please read these terms & conditions carefully before ordering your Yard Card Greeting. You should understand that by ordering any of our products, you agree to be bound by these terms & conditions.

- 1. **PAYMENT.** Payment is due at time of booking and payment must clear within 24 hours of delivery. Payment information is transmitted over secure SSL encryption and is not stored.
- 2. **CANCELLATION.** If you need to cancel your order prior to the day of your session delivery, please give us 24 hours' notice. We reserve the right to refund 1/2 of your payment if cancelled less than 24 hours in advance, or you have the option to reschedule for the full value paid. Cancellations made the day of scheduled delivery may not receive a refund.
- 3. **RUSH ORDERS.** Rush and same day orders will be accommodated with the following conditions:
  - Based on available inventory
  - Rush fee may apply
  - Orders placed within 24 hours of requested event day are not guaranteed
  - o Order will be refunded we are unable to complete your order.
- 4. INCLEMENT WEATHER. We will not be able to deliver your Yard Card Greeting if there is lightning or other hazardous weather conditions that prevent set up and/or take down. In the event of prohibitive weather or inclement weather, if we are unable to reschedule the greeting a refund will be given.
- 5. **REFUND POLICY.** We will not refund payment if recipient requests the Yard Card Greeting to be removed. We will not refund payment for errors that occur on order submission.

Yard Card Greeting should not be moved without consent from the owner. You are responsible for replacement of the graphic, letter, or stake at full replacement value. Full payment for any signs that are damaged will be enforced.
